**Narrative**

I was dispatched to 391 West Duncan Loop, Apartment 301, in reference to a burglary.

Upon my arrival I met with complainant, Michael Capuano. Michael said that he and his wife, Desiree Capuano, left the apartment at 0700 hours this morning and returned home to find that their front door was unlocked. When they entered the apartment, they noticed that their Toshiba laptop computer was missing. Michael said he knew it was there when he left because he had put it on the

kitchen counter and plugged it in to charge.

Michael said no one but maintenance personnel has the key to the apartment and it was locked when he left. Michael also showed me that there was a black scuff mark on the floor in front of the counter and a black hair on the counter where the computer was. Michael also pointed out that there was electronics still in the box that were not touched.

I asked Michael and Desiree to look around to see if anything else was missing. Desiree noticed that a box on the floor containing Playstation games was open and the games were missing.

I did not notice any forced entry and the door peephole was clear. Per Detective Kanehl, the lock was checked and the key was still operational.

While speaking to the residents at 391 West Duncan Loop, Apartment 301, I was approached by Anthony Servidio and Chantal Servidio, who live in the same apartment building in Apartment 303.

Anthony and Chantal told me their apartment had been broken into sometime today and their laptop computer was missing. Chantal explained that she and Anthony had left the apartment at 0800 hours this morning and when they returned tonight, they noticed the laptop that had been on the coffee table, was gone. I asked Chantal to check and see if there was anything else missing. Anthony then noticed that his digital camera was also gone.

I went around to each apartment and spoke to other residents, asking if they had seen or heard anything suspicious today. I was told by John Varling, who lives in Apartment 101, that on 11-28-05, he noticed a white Jimmy truck setting outside the apartments at approximately midnight. John said it was occupied by three subjects who turned the dome light out and reclined their seats when they saw John approach. John did not get the tag number to this vehicle.

I then spoke to Angela Wilson, who lives in Apartment 201. Angela told me that she came home at approximately 1245 hours this afternoon and noticed a maroon LeSabre in the parking lot, but did not know who occupied it. Angela stated she has never seen this vehicle before. Angela also told me that she received a parking citation by the Courtesy Officer at 1103 hours this morning.

I spoke with Benjamin Cooksey, the Courtesy Officer, who told me he was outside the apartments at 1100 hours this morning issuing a citation, but did not see anything strange or anyone out of the ordinary around the apartments.

I then spoke to Juan Guzman, who told me that he is a maintenance man for the apartment complex. Juan stated that if the break-in was committed by an employee of the apartment complex, the keys for the apartment would have had to be checked out on a log. He informed me that he would notify his supervisor to pull the record first thing in the morning.

Forensics was requested and Specialist Erwin responded and processed Apartments 301 and 303.

All victims were provided business cards with their respective case numbers.

I then notified Detective Kanehl of the burglaries.

responded to the occurred at the request of Dep. Tsanakaliotis, reference a residential burglary. I was advised upon my arrival that there had been another burglary across the hall in apartment #303 (see 05-300621).

There was no signs of forced entry to the apartment, which was located on the third floor.

A laptop computer had been taken off the kitchen counter. There was a black scuff mark on the kitchen floor that I was advised was not from the residents of the apartment. There was also what appeared to be a black hair on the counter near where the laptop had been taken from. I was also advised that this did not belong to the residents of the apartment.

Several video games had been taken from a shoe box on the living room floor.

I photographed the exterior and interior of the apartment, documenting the above.

I collected the possible hair from the kitchen counter and placed it into a pharmaceutical fold.

I collected the bottom portion of the shoe box to be processed later at FSD. The top portion of the box was not conducive to latent processing.

I processed the kitchen counter area for latents, obtaining negative results.

At approximately 0152 hours, I sprayed the shoe box with Ninhydrin and left it to dry in the fuming hood. I then secured it into my evidence locker, pending latent development.
