Narrative

On 07/20/15 I was dispatched to 3849 49th Ave in reference to a Domestic. Per the call notes, the complainant stated his parents were physically and verbally fighting in the living room.

When I arrived on scene I observed a shattered clay pot against the front door which appeared to have been thrown as the contents were scattered across the front porch. Through the front door I observed a female later identified as Amanda Capuano crying and screaming on the couch in the living room at her husband, Michael Capuano. In the back bedroom appeared a juvenile male,

who was crying and on the phone with 911.

I made contact with Michael and asked him to speak with me outside of the residence. Michael had blood actively dripping from his left earlobe onto his brown t-shirt which was ripped from the left collar to his shoulder blade. On the upper portion of his left eyebrow was shallow laceration approximately three inches long consistent with a scratch caused by fingernails. On the left side of his chin I observed a small bloodied abrasion as well as the middle portion of the right side of his neck. On Michael's right inner bicep there appeared to be a fresh bite mark with teeth marks surrounding the moderate bruising. Michael's lower left arm had numerous scratch marks consistent with fingernail scratches.

I asked Michael to explain what occurred prior to my arrival which he stated he got into an argument with his wife of two years, Amanda, due to her having medical issues. Michael further stated Amanda was in a bad mood for most of the night however refused to acknowledge how he obtained his injuries. Michael stated Amanda had been depressed for some time and advised she possibly scratched him during a verbal argument. Michael stated numerous times he did not want Amanda to go to jail for his injuries.

Michael gave consent to enter the residence and I observed in the living room miscellaneous broken items which appeared to have been thrown against the far west wall. Amanda was still sitting on the couch sobbing and when I asked what happened she stated she got into a verbal argument with Michael which turned physical however refused to provide any specifics. Amanda stated Michael becomes abusive when he has nicotine withdrawals and advised he "attacked" her. When asked to elaborate Amanda refused. I did not observe any injuries to Amanda which would be consistent with her being "attacked". Amanda did not wish to reveal any further information.

I spoke with [redacted], Michael's son and Amanda's step-child who stated both subjects were fighting throughout the night due to Amanda not feeling well. [redacted] stated that his parents were in the living room yelling at each other when Michael told him to go into the other room to play on his computer. [redacted] advised "One thing led to another and it escalated quickly" further stating "she pushed him into the wall and he hit his head." [redacted] said both subjects were pushing each other back and forth which lasted approximately one minute.

[redacted] believed Michael's injury to his ear was caused by being pushed against the wall. [redacted] advised he has never seen his parents physically fight before and explained he lives out of state in Arizona full time and would be leaving to return home in the morning.

Due to [redacted] not living in Florida and only being at the residence temporarily DCF was not notified.

At this time due to Michael's extensive fresh injuries and statements provided by all parties Amanda was taken into custody for Domestic Battery.

I photographed Michael's injuries which were attached to this report. I provided Michael with a Domestic rights pamphlet/ brochure before leaving the residence. I completed a VIPAR arrest affidavit and Amanda was transported to County Jail by prisoner transport without further incident.

Disposition: Case Closed, Solved with Arrest.
